For (Individual Certification) (Example: Iridologist, etc.) there is a onetime certification/registration fee of \$400 for (Individuals). This is onetime and not annually. This is for Certified Health-Related Practitioners and Christian School Instructors.

Minister's Ordination is \$40 a year to be renewed annually and subject to an annual minister's report for verification.

The degree award fee is a onetime \$500 fee per degree sought. This refers to the D. Min. (Doctor of Ministry Degree) and the D. Sc. (Doctor of Science Degree) with a Major in (Therapy)

We ask that you please pay the appropriate registration fee for the credential being sought upon submission of your application. Your fee will be returned if you do not receive credentials.

Please provide with your application letters of recommendation from 2 Christian Church-Related sources. One should be from a pastor and the second from a respectable non-relative Christian individual. These letters should confirm your activities and qualify your Christian character.

Please provide with your application copies of any and all relevant documentation supporting your assertions as to your qualifications and activities... such as but not limited to: licenses, certifications, awards, public advertisements, professional telephone listings, educational diplomas, continuing education verification and etc.
